

Best wishes.



**MEMORANDUM OF CO-OPERATION
BETWEEN
THE UNIVERSITY OF AVEIRO
AND
THE UNIVERSITY OF GOA**

Considering that

1. The University of Aveiro and the University of Goa are both relatively young Universities and may have development strategies, global as well as specific, which may be beneficial to share.
2. Both Universities are coastal-based Universities and therefore share some common regional characteristics related to the economic and industrial life based on marine resources.
3. A considerable part of the population in Goa can understand and therefore communicate at a reasonable level in Portuguese, the language of instruction in the University of Aveiro.

The two Universities represented hereby their Reitora and Vice-Chancellor, respectively, Professor Doutora Maria Helena Vaz de Carvalho Nazare and Professor P. S. Zacharias resolve to undertake knowledge sharing programme through the exchange of scholars, knowledge data sources and thereby co-operate in the development of each other under the conditions specified in the following section terms of Agreement.

Section 1

Each University will promote the exchange of scholars (faculty members and students) in order to participate in formulating and in carrying out collaborative research projects which will lead to the development of expertise of both Universities in the respective area of inquiry.

Section 2

1. Each University will promote travel of its scholars to the other University to participate in the congress, conferences and workshops hosted by the other.
2. The exchange visits are considered as part of the normal academic work and therefore adequate study leave or equivalent shall be provided for.

Section 3

The host University will provide free accommodation and reasonable subsistence allowance to the visiting faculty member according to his status in the home University.

Section 4

The travelling expenses will not be, in general, responsibility of the host University.

Section 5

The total duration in man-months of guest facilities provided by each University in a given year would be decided annually and communicated to each other by the respective heads of the institutions.

Section 6

In order that the collaboration may lead to fruitful results, the host University takes the responsibility of providing the infrastructure and other necessary facilities for the successful outcome of the visit. The necessary facilities for each visit will be agreed upon before commencing the visit.

Section 7

For each visit the visiting scholar will write a brief report of his work achievement and other comments which will be countersigned by the head of the Unit where the work was carried out.

Section 8


This agreement will remain valid from the date of signature and may be terminated by either institution on six months notification in writing to the other partner.

Section 9

This agreement is written in four copies, two in Portuguese and two in English, both texts having the same meaning.


